The same applies to the entire module.</p> <p>Rule in Case of Unsatisfactory Written Paper If the part 'written paper' (80%) is considered unsatisfactory and the student in question cannot reach a total grade that would be sufficient (4.0) with his/her defense (20%), the following rule applies: The main supervisor notifies the student before the date set for the defense that he/she has failed the written part of the performance assessment. The student decides whether or not to attend the defense part of the performance assessment and informs his/her main supervisor accordingly. If he/she decides in favor of a defense, the total grade is calculated from the weighted grades for the written paper (80%) and the defense (20%). If he/she decides against a defense, the grade awarded for the written paper will be the final module grade.</p>
